

Revisions to 201 KAR 18:

192 - The Board of Licensure proposed changes to the Continuing professional development (C.P.D.) for Professional Land Surveyors regulation. Pre-Approval of seminars for continuing professional credit has never been required but, we have always had the option to get the course approved. The gist of the revisions is to remove the "Option" of seminar and course pre-approval. We asked for feedback from KAPS members and surveyors across the Commonwealth. Based on the feedback we received and a lengthy discussion at our April 09, 2011 Board of Directors meeting we drafted a letter stating our support of the continuation of the current regulation. The



letter was well received and generated discussion in the CPD Committee meeting. In their meeting on April 14, 2011, the CPD committee voted on and recommended to the full board on April 15, 2011 not to pursue the revisions to the KAR as written. The CPD committee did direct the board staff and general council to draft language revising the KAR. The revisions are to be presented to KAPS and the board of licensure before their meeting in July, a brief summary of the revisions are: 1. Approve providers in lieu of approving courses, and 2. Remove KAPS and KSPE as members of the CPD Committee. The removal of a KAPS and KSPE member from the committee stems from being in direct conflict with the Governors Ethics Proclamation as stated in Executive order

2008-454 dated May27, 2008. Please keep in mind the meetings are open to the public and us. In discussions they made it very clear that we were welcome to attend, but being listed as a member by regulation is a conflict of interest.

In closing, thank you for the opportunity to serve you. I promise that I will serve the membership and the Board of Directors to the best of my ability. I will strive to achieve any goals that we set and to keep KAPS and the surveying profession moving forward and in a positive direction. I look forward to visiting with our membership throughout the year and will to do my best to get new members involved in KAPS. I truly look forward to making new friends this year.

Staff Member

We would like to welcome Sandy Whisman as our newest staff member. Sandy comes to us from the Administrative Office of the Courts where she worked as an assistant to circuit judges for over twenty years. She will work in our enforcement and legal areas as an Administrative Assistant.

Continuing Education for Surveyors

Our January 2011 report discussed the Board's consideration of removing the optional preapproval of courses language from the continuing education regulation, 201 KAR 18:192. Currently, providers have the option of submitting courses to the Continuing Professional Development Committee (CPDC) for preapproval. The continuing education regulation for engineers does not offer the preapproval option.

The Board did not take action on this issue during the April meeting and is currently considering the option of offering optional preapproval of providers instead of specific courses. A change in the composition of the CPDC is also being considered.

Licenses and Permits

Individual licenses are valid for two years and expire June 30. Those with last names of A-K expire in odd years and those with L-Z in even years. Post card renewal notices are mailed in May and give the online address to renew. We do not renew via mail. If you have problems, call our office and we can assist over the telephone. There is a 10% penalty per month for late renewals up to one year. After that, reinstatement is required. A renewal later than September 1 will also trigger an automatic continuing education audit. Please renew timely to avoid penalties, automatic continuing education audits, and possibly having to apply for reinstatement of your license.

Business Entity Permits expire annually on December 31. Post card renewal notices are mailed in November and give the online address to renew. We do not renew via mail. If you have problems, call our office and we can assist over the telephone. There is a 10% penalty per month for late renewals up to one year. After that, reinstatement is required.

You are responsible for renewal even if the post cards are not received. We suggest setting up a reminder system in your calendar, computer, smart phone,

etc. You can check the status of your license or permit using our searchable roster at <http://apps.kyboels.ky.gov/SearchableRoster.aspx>

Expiration of Surveying Licensure Routes

On June 30, 2011, three routes currently available for surveying licensure will expire. If you have been approved for the Fundamentals of Surveying (FS) exam under one of the expiring options before that date, you will be allowed to continue, subject to the three exam attempts limitation.

If you have not yet been approved for the FS exam, you must apply as soon as possible. The application must be approved by the June 30 deadline; not just received by that date. In order to approve, we have to verify employment, references, receive transcripts, etc.

The three routes expiring are "experience only", two year surveying degree, and four year ABET accredited program other than land surveying.

The three routes remaining after June 30, 2011 are a four year surveying degree, an ABET accredited civil, mining, or agricultural engineering degree plus 12 hour surveying core curriculum, or any other four year accredited degree plus 24 hour surveying core curriculum.

Board Disciplinary Actions

For The Period January 8,
2011 – April 15, 2011

MANSEL SHANE KRIMM,
PLS

In June 2010, Mr. Mansel Shane Krimm, PLS of Bardstown, KY was selected for an audit of his Continuing Professional Development (CPD) hours. After Mr. Krimm failed to respond to the audit, the matter was referred to Enforcement. A brief investigation revealed that Mr. Krimm had indicated on his online license renewal application that he had complied with the CPD requirements when in fact, he had not complied. Mr. Krimm had no record of participation in any CPD activities for the entire audit period. Mr. Krimm's failure to respond to the CPD audit and his failure to participate in the required CPD activities constitute violations of 201 KAR 18:192. The false reporting of compliance with the CPD requirements on the renewal application constitutes a violation of KRS 322.180(1). The matter was settled by a Consent Decree wherein Mr. Krimm acknowledged the violations and agreed to the following sanctions: (1) A 90 day suspension of his land surveyor's license, (2)

A \$2000 fine, (3) an online correspondence course in Surveying Ethics, (4) Mr. Krimm must take makeup CPD classes for calendar years 2008, 2009, and 2010. (5) Mr. Krimm must take double the normally required amount of CPD classes for calendar years 2011 and 2012. The Board of Licensure approved the Consent Decree on April 15, 2011.

RALPH E. PRICE, PE

In 2010 the Board received information that Mr. Ralph E. Price, PE of Bedford, Indiana had certified a bridge design using his Indiana PE license stamp. An investigation revealed the Mr. Price had provided professional engineering services on a number of Kentucky bridge projects before he was licensed in Kentucky. Mr. Price had subsequently obtained a Kentucky PE license by comity. The investigation also developed serious concerns as to whether or not Mr. Price was obtaining adequate site topographic, geotechnical and hydrographic information on which to base his designs. Mr. Price's work on Kentucky projects before he was licensed in Kentucky constitutes unlicensed practice, a violation of KRS

322.020. The matter was settled by a Consent Decree wherein Mr. Price voluntarily surrendered his Kentucky professional engineering license. The Board of Licensure approved the Consent Decree on April 15, 2011.

JERRY LEE CANNON, PLS

In February 2011, Mr. Jerry Lee Cannon, PLS, of Crittenden, Kentucky was arrested by Federal authorities on charges relating to the alleged distribution of child pornography. Mr. Cannon has since been transferred to Mobile, Alabama where those charges will be adjudicated. Prior to his departure to Alabama, Mr. Cannon signed a Consent Decree wherein he agreed to an immediate suspension of his professional surveying license. Under the terms of the agreement, the suspension shall convert to a revocation if Mr. Cannon is adjudged guilty of any crime relating to the charges. In the event that Mr. Cannon should be exonerated, or if the government should drop the charges, Mr. Cannon's license would be restored to active status. The Board of Licensure approved the Consent Decree on April 15, 2011.







Continuing Professional Development Revisions to 201 KAR 18:192

The Kentucky State Board of Licensure for Professional Engineers and Land Surveyors is and has been considering revisions to Continuing Professional Development for Professional Land Surveyors, 201 KAR 18:192. The current surveyors' regulation does not require pre-approval of seminars for CPD credit, but it does provide the option to get pre-approval of a seminar for CPD credit. The primary change originally proposed to the regulation was to remove the option for pre-approval.

The Kentucky Association of Professional Surveyors (KAPS) was provided the opportunity to review the proposed revisions to 201 KAR 18:192 and provided the time to share the opinions of surveyors around the Commonwealth. We asked for feedback from KAPS members and surveyors across the Commonwealth. Based on the comments and feedback we received and after a lengthy discussion at our April 09, 2011 Board of Directors meeting, by a unanimous vote, KAPS supported the continuation of the current 201 KAR 18:192 regulation. A letter was drafted outlining our opinion, discussions and reasoning with regard to support of the current regulation. The letter was issued to Mr. Ben T. Quinn, PE, PLS, Board Chairman of the

Board of Licensure, Mr. Dennis D. Smith, PE, PLS, Chair of the Continuing Professional Development Committee, Mr. David Cox, Executive Director and Mr. Jonathon Buckley, General Council prior to the April 14, 2011 committee meetings and the April 15, 2011 Board of Licensure board meeting.

I was in attendance for the Board of Licensure CPD and Survey Committee meetings on Thursday April 14, 2011 and attended the Board of Licensure board meeting with Chris Gephart, our Board of Licensure liaison on Friday April 15, 2011 in Frankfort, Kentucky.

The letter was well received and generated discussion in the CPD Committee meeting. The CPD committee voted on and recommended to the full board **NOT** to pursue the revisions to the KAR as written.

The CPD committee did direct the board staff and general council to draft language revising the KAR. The revisions are to be presented to KAPS and the board of licensure before their meeting in July, a brief summary of the proposed revisions as I understand them are as follows:

1. Approve providers in lieu of approving courses.

- a. The current regulation would be in effect until such time language could be drafted, approved by the B.O.L. and ultimately approved by the LRC. The providers of courses would be approved and not the actual course work or seminars.

2. Remove KAPS and KSPE as members of the CPD Committee.

- a. Currently the committee, by regulation, is made up of as follows:
 - i. Section 2. Continuing Professional Development Committee. (1) The chair of the State Board of Licensure for Professional Engineers and Land Surveyors shall appoint a Continuing Professional Development Committee and name its chair. (2) The CPDC shall consist of four (4) board of licensure members of which at least two (2) are professional land surveyors. In addition, the Kentucky Association of Professional Surveyors and the Kentucky Society of Professional Engineers shall each appoint one (1) nonvoting member.
- b. The reasons given at the committee meeting for the removal of the KAPS and



KSPE members are:

- i. A member of the associations sitting on the committee (non-voting or not) gives the perception of an unfair advantage with regard to approval of a seminar, course work or a provider.
- ii. A member of the associations being on the committee is in direct conflict with the Governors Ethics Proclamation as stated in Executive order

2008-454 dated May27, 2008.

iii. Please keep in mind when you read this, the meetings are open to the public and us. We can attend the meetings. In discussions they made it very clear that we were welcome to attend, but being listed as a member by regulation is a conflict of interest, based on the opinions of the attendees at the meeting.

Once we receive the proposed revisions from the board of Licensure we will circulate the information to members and surveyors around the Commonwealth for your review and feedback. We have a KAPS Board of Directors meeting on June 17, 2011. This will be on the agenda for discussion.



Richard Montgomery wished to discuss an item under Old Business

and Tom Bushelman wished to give an update on the KAPS Brochure.

MINUTES OF THE JUNE 18, 2010 BOARD MEETING

After the members reviewed the minutes of the June 18, 2010, board meeting, Jim Riney made a motion to approve the minutes as presented. Seconded by Joe Mylor. Motion passed.

GUEST SPEAKER

Executive Secretary's Report – Betty Gray submitted a written report mainly for informational purposes. She reported that since the Board had voted to get rid of the postage machine, she had sent back the machine to Pitney Bowes and that this should result in a substantial savings for KAPS. The exhibitors packets have been sent out and four booths have been sold for the 2011 Annual Conference. She is working with Bill Jones on plans for the conference. KAPS now has a new KAMP Liaison. Steve Lilley has accepted this position.

OLD BUSINESS

Chuck Felts wanted to remind KAPS Statute of Repose Committee there would be a meeting just after the board meeting. There was a question on what matters the meeting would deal with. Mr. Felts has approached the county attorney in Laurel County and asked him if KAPS qualifies for a statute of repose for professionals. He is of the opinion that KAPS does qualify for the statute of repose, that KAPS meets the standards. surveyors. He also wanted board members to check with engineers and see if they would oppose this for land surveyors. Statute of repose is an attempt to limit the timeframe in which a land surveyor is responsible for their surveys. Governor. Don Pedigo made a motion to give Mr. Cox the authority to sign the letter accompanying the submittal. Seconded by Tom Clayborn. Motion carried.

President Cox suggested a by-laws change be made. He said that a situation had arisen earlier this year whereby KAPS needed to make a decision within a short time period and it was impossible for them to do so. Highlands – No written report. Johnny Justice said they had not met during the summer. They will hold their next meeting October 5, 2010 at Landmark Inn, Pikeville.


Northeast – No written report. David Dummer said they had been having regular meetings this summer with fair attendance. At one of their meetings they had someone from Carlson Software give a demonstration.



The next board meeting will



come back to the April board meeting with more details.




KAPS Chapters Boundary Map
